Dependency and Indemnity Compensation (DIC) for 2024

Basic Monthly Rate = \$1,612.75, with 1 Child \$2,012.79, with 2 Children \$2,411.83, etc.

Allowances: with A&A \$2,012.29, with Housebound \$1,799.92, w/ 8 Yrs Continuous Disabled \$1,955.21

1. Add **\$342.46** for veteran's death, if veteran was in receipt of or entitled to receive compensation for a service-connected disability rated totally disabling (including a rating based on individual unemployability) for a continuous period of at least 8 years immediately preceding death AND the surviving spouse was married to the veteran for those same 8 years. (38 U.S.C. 1311(a)(2))
2. Add the following allowance for each dependent child under age 18: Effective 12/1/14 **\$399.54** per child (38 U.S.C. 1311(b))
3. If the surviving spouse is entitled to Aid and Attendance, add **\$399.54** (38 U.S.C. 1311(c))
4. If the surviving spouse is entitled to Housebound, add **\$187.17** (38 U.S.C. 1311(d))
5. If the surviving spouse has one or more children under the age 18 on the award, add the 2-year transitional benefit of **\$342** effective, December 1, 2014 (38 U.S.C. 1311(f))
